

# Authors: The Psychoanalytic Review

## Information for Authors

The *Psychoanalytic Review* publishes peer-reviewed contributions to the literature on psychoanalytic theory and practice, including interdisciplinary applications that advance psychoanalysis as a body of knowledge and therapeutic discipline. Articles report original research on relevant theoretical questions; clearly communicate new clinical hypotheses, observations, or approaches; advance issues within psychoanalytic education; and enhance overall understanding of human behavior.

The *Psychoanalytic Review* accepts in-depth psychological manuscripts from all schools of thought on a wide range of theoretical, clinical, and cultural concerns. Research methodologies may be quantitative or qualitative, as well as based on individual cases when persuasively applied to a general topic within the journal's purview. On occasion, articles and concurrently published commentaries on articles are invited, as are articles for Special Issues on dedicated topics. *The Psychoanalytic Review* also critiques pertinent books and films.

## Manuscript submission

Manuscripts should be submitted electronically to the Editor at [\*\*ThePsychoanalyticReview@npap.org\*\*](mailto:ThePsychoanalyticReview@npap.org).

Articles will be accepted only if they are contributed solely to *The Psychoanalytic Review*. The Editor should be notified if the article has already appeared in a foreign-language journal or has been submitted elsewhere. The journal does not typically republish material and will not consider for publication in the journal any material previously published online—whether self-published on an author site or a research site used by a university or society, such as IJP Open—since there are no clear criteria for distinguishing which is the article of record or for enforcing publication rights.

The journal follows a double-blind peer review process. Authors should send the manuscript as an attachment in Microsoft Word or a Word-compatible format, with a separately attached blind copy that has the name(s) of the manuscript's author(s) in citations and references replaced by AUTHOR.

Often a paper is accepted contingent upon revisions required by reviewers, or the retyping of references in the style of this publication. Authors are responsible for these changes as requested by the Editor.

A complimentary copy of the issue in which the paper appears will be sent to the author. The opinions and views of the contributors do not reflect the viewpoint of the editors or the National Psychological Association for Psychoanalysis (NPAP).

There are no fees or charges associated with publishing in the journal.

## A Special Note about AI

At this time, the Journal does not allow the use of artificial intelligence (AI) to create article content. This includes, but is not limited to, figures, tables, images, and text. Authors are welcome to use AI to check grammar but should be aware of the terms and conditions; companies may use your work to train their models.

## Copyright

Authors must return a signed copyright transfer agreement upon acceptance for publication. A copy of the agreement to be used for the *Psychoanalytic Review* is available from the Editorial Office. By signing the agreement, authors guarantee that an article is original, that it is being submitted exclusively to this journal, that it has not been previously published (except in abstract form), and that any clinical material is disguised so as to prevent the subject from being identified.

## Manuscript formatting

Manuscripts should be double-spaced, with at least a one-inch margin on all sides. Notes should conform to the style of recent issues of this publication. Effort should be made to keep notes at a minimum.

Provide an abstract of about 100 words, and a separate biographical note with the authors' academic degrees, professional titles, affiliations, and mailing address.

**Tables** should follow the Publication Manual of the American Psychological Association, 7th ed. They may be submitted in Excel or formatted using Microsoft Word's table function. (Tables should not be submitted using tabs, returns, or spaces as formatting tools.)

Tables should be provided at the end of the manuscript text, or as separate Word or Excel files. All tables must be referenced in text, in sequential order.

**Figures** must be submitted as separate files (not embedded in the manuscript). All figures will be published in grayscale.

Figures should be submitted in one of the following formats: .tif, .jpg, .eps (.bmp, .png, and .gif files are not recommended). PDFs are not accepted. Figure text should be 8–10 pt. sans serif type.

A list of figures with captions, keys, and credits should be provided at the end of the manuscript text. All figures must be referenced in text, in sequential order.

**Confidentiality:** It is the author's responsibility to disguise the identity of patients when presenting case material. See, e.g., Clift, M. A. (1986), **Writing about Psychiatric Patients: Guidelines for Disguising Case Material**, *Bulletin of the Menninger Clinic*, 50(6),1–13 (posted on the Guilford website); and Kantrowitz, J. L. (2004), Writing About Patients: I. Ways of Protecting Confidentiality and Analyst's Conflicts Over Choice of Method. *Journal of the American Psychoanalytic Association*, 52, 69–99 (available on PEP).

**Permissions:** Contributors are responsible for obtaining permission from copyright owners if they use an illustration, table, or lengthy quote (100+ words) that has been published elsewhere. Contributors should write both the publisher and author of such material, requesting nonexclusive world rights in all languages for use in the article and in all future editions of it.

**Text documentation:** Citations in the text of the manuscript should provide the author's name and, in parentheses, the year of the original publication of the paper or book. *Example:* "Freud (1914) said . . ."

If the author's name does not naturally appear in the sentence of the text, place in parentheses the author's name, followed by a comma and the year of the original publication. For two or more publications, use semicolons to separate the names of authors. *Example:* There have been many reports (Beres, 1956, 1958; Pine, 1974).

Whenever material is quoted verbatim, cite a page reference in parentheses. *Example:* Lacan (1977) writes: "It is striking that Levi-Strauss . . . is already conquering the very terrain in which Freud situates the unconscious" (p. 73).

**References:** Authors should consult the Publication Manual of the American Psychological Association (7th ed.) for reference format and style. Any manuscripts with references that are incorrectly formatted will be returned to the author for revision.

For Freud's works, the original date of the paper or book is given first, and the date of its appearance in the *Standard Edition* is given at the end of the reference:

Freud, S. (1911). Formulations on the two principles of mental functioning. In J. Strachey (Ed. & Trans.), *The standard edition of the complete psychological*

*works of Sigmund Freud*, 24 vols. (Vol. 12, pp. 213–226). Hogarth Press, 1957–1974.

\_\_\_\_\_ (1925). Negation. *Standard ed.*, 19, 233–239.

Refer to recent issues of this publication for additional examples of style for Freud references.

## Publication ethics

### Disclosure of conflicts of interest

The *Psychoanalytic Review* requires that authors disclose all potential conflicts of interest. Any interest or relationship, financial or otherwise, that might be perceived as influencing an author's objectivity or exerting an undue influence on the presentation of their work is considered a potential conflict of interest. These may include, but are not limited to financial, professional, contractual, or personal relationships or situations.

Authors should include a statement in the title page detailing all potential conflicts of interest. If the manuscript has multiple authors, all contributing authors must disclose conflicts of interest.

For additional guidance, refer to the recommendations in the Publication Manual of the American Psychological Association (7th ed.).

**Sample wording for your disclosure statement:** "Author A is employed at company B. Author C owns shares in company D and is on the Board of Company E. Author F has received grants from [name of grantor] to support the research described in this article."

If no conflicts of interest exist, the declaration should state “Disclosure Statement: The authors declare no conflicts of interest.”

## **Funding statement**

The manuscript must include a funding statement detailing all sources of financial support, including grant numbers if applicable.

**Sample wording for your funding statement:** “This research was supported by an award from the National Institute of Mental Health (grant number XXXX).”

Grants held by different authors should be identified as belonging to individual authors. For example: “This work was supported by the National Institutes of Health (Author A, grant number XXXX), (Author B, grant number YYYY).”

Where no specific funding has been provided for research, authors should state “The author(s) received no specific funding for this work.”

## **Authorship**

The *Psychoanalytic Review* refers to **the American Psychological Association (APA) guidelines for authorship** and the **APA Ethics Code**.

Individuals who have made a substantial contribution to the article as defined in the **APA guidelines** should be listed as authors. Contributions that do not meet the criteria for authorship may be recognized in an Acknowledgment note.

Upon acceptance of the article for publication, each author must confirm in writing that they approve the authorship order and agree to the responsibilities of authorship.

## **Ethics statement**

Articles that report the results of research with human participants must include an ethics statement in the following format:

This study was reviewed and approved by [full name and affiliation of ethics committee], and the procedures followed were in accordance with the Helsinki Declaration as revised in 2013. The patients/participants provided their written informed consent to participate in this study.

For guidance, authors should refer to the **APA Ethics Code** and the **World Medical Association Declaration of Helsinki**.

## **Scientific or publishing misconduct**

The *Psychoanalytic Review* editors and Guilford will review **the Committee on Publication Ethics (COPE) Flowcharts** in the event of an allegation of scientific misconduct (including—but not limited to—fabrication or falsification of data, purposeful failure to disclose conflicts of interest or funding sources, and plagiarism); duplicate publication (see **COPE guidance**); or manipulation of the publishing or peer review process.

## **Corrections**

The *Psychoanalytic Review* may publish a correction notice if a published article is found to contain a significant error or omission—for example, an omitted author name or a misprinted figure. An erratum will be published in the next available issue of the journal and will be made freely available online.

## **Retractions**

The *Psychoanalytic Review* will consider retractions in accordance with the **Committee on Publication Ethics (COPE) Retraction Guidelines**.

Requests to retract an article will be investigated by the editors in consultation with Guilford.

## **Green Open Access**

***Green open access*** (also known as self-archiving) allows authors to make a version of their work freely accessible in an institutional or disciplinary repository. Guilford authors may deposit either the published PDF of their article or the final accepted version of the manuscript in a non-commercial repository, where it can be made freely available, six (6) months after publication in the journal. Deposited manuscripts must include full citation of the work along with a link to the product on Guilford's website (i.e., the DOI link).

## **Content preservation**

Periodicals published by The Guilford Press are deposited in the **Portico** archive to guarantee long-term digital preservation.
